I am writing you because my lawyer, Patrick Amazon has told my mother that he won't give you the Facebook messages I provided to him showing that my prosecutor, Mark Johnson there requested me on Oct. 29, 2022. He has been messaging me since I got back from rehab and up until I had a Houston County officer lie and pull me over out of his jurisdiction. I'm being harassed, set up, and exploited. I'm in fear for my safety from Houston County and I finally can prove it and have people willing to listen. Cheryl Leatherwood, the Director of Community Corrections for Dale County will attest to what the police have been doing to me since this whole thing started in 2017. She is my biggest witness in all of this. Anthony Hail and Griffin have been trying to hurt me. I can and WILL prove all I'm telling you.

I have written to the Attorney General. I am

writing to the Judiciary Ethics Committee and the Alabama Bar Association. I have a lawyer Kerrie Oaden in Dale County that is actually working to help me.

Patrick Amazon has the messages, considering I can't bond out because I am in fear for my safety I want the hold lifted from Houston County and will be more than happy to show up in court in front of you. **Please allow me to ~~do~~ do so with people that will protect me.** The messages will prove the gross ethics violation on the part of the DA's office. Because I can't get into my phone right now I can't produce the pictures from my messenger. But I'm sure that I wouldn't make up something like this and have already gotten copies to my other attorney.

I'm asking for a mistrial and I'm asking for the bond from Houston County to still be in effect. Once I get the video footage from the gas station in Daleville that

Giffen (Doran) pulled me over  
out of his jurisdiction, that  
will prove that he lied about  
why he pulled me over and  
this will be dropped in  
Dale County. But the fact  
remains that I have been  
a victim of the police and  
now the assistant district  
attorney. I have provided  
documentation and am being  
told by my own lawyer,  
once again, that he basically  
has no interest in the  
truth, he only wants to  
help bury me. When all  
I have done from the  
beginning is comply with  
law enforcement. Nobody cares  
that I'm the one being  
run out to dry.  
 subpoena Mr. Johnson's phone,  
I know that nothing is  
ever truly erased. I'm sure  
that when this is brought  
before the Judiciary Ethics  
Committee they will find that  
I'm telling the truth, and  
Cheryl Leatherwood is also  
an officer of the court. She  
will be more than happy  
to tell you what these people

have done and are doing now. I'm not the only one either, I can prove that too.

My family is willing to go to the press with this. I've asked Mr. Amason to file a motion for a mistrial but I'm experiencing resistance from him due to the personal relationship he has with these people? I get it, that's why I know I'm in danger.

Please lift this hold on me so that I am not placed in the custody of people that want to hurt me. I'm afraid for my life.

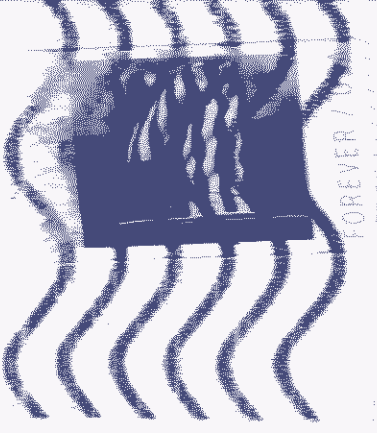
